## **INTRODUCTION**

Assembly Bill 107 (Salas, Chapter 693, Statutes of 2021) requires that the Department of Real Estate collect information about military, veteran, and spouse license applications, including the number of expedited licenses issued and denied per calendar year, and the average length of time between application and expedited license issuance. It also requires the Department to report this information annually to the Legislature. The following report has been prepared based on information gathered by the Department of Real Estate.

Assembly Bill 107 requires that the Department of Real Estate retain and report the following information:

- The number of applications received for expedited initial licenses submitted by veterans who were honorably discharged.
- The number of expedited licenses issued and denied for honorably discharged veterans.
- The number of applications received for expedited licenses for applicants who are married to, in a domestic partnership, or in a legal union with an active duty service member, and who hold a current license in another state
- The number of licenses issued and denied for expedited licenses for applicants married to, in a domestic partnership, or in a legal union with an active duty service member, and who hold a current license in another state.
- The average length of time between license application and issuance for these licenses, by license type.

## Summary

The Department received 649 applications from veterans who were honorably discharged in calendar year 2022. Of those, 614 were processed in 2022 and all were approved. The Department also received 57 applications from those who are married to, in a domestic partnership, or in a legal union with an active duty service member in calendar year 2022. Again, no such applications were denied and 54 were approved in that calendar year. Each of these applications was approved on an expedited timeline, averaging 15.1 days for salesperson

applications, 28.2 days for broker applications, and 37.6 days for corporate officer applications.
