License Information

Original License — If you have applied for an original license and have received a "Notice of Withholding," you will not be issued a full term license until both the \$95 fee and the proper Department of Child Support Services (DCSS) release have been submitted, as stated in the enclosed letter. When both the proper DCSS release and \$95 payment have been received within your 150 day temporary license term, a full term license will be issued. If the fee is not submitted within your 150 day temporary license term in conjunction with your DCSS release, your license status will become withheld/denied. If, at time of payment, you are within one year from your examination date and wish to reapply for your license, you will be required to submit the \$95 fee in addition to a new original license application and appropriate license fee. If, at time of payment, the one year period in which to apply for an original license has expired, it will be necessary for you to requalify through the examination process if you again wish to obtain a license in real estate. Once the examination has been passed, you will still be required to submit the \$95 fee in addition to a new original license application and appropriate fee.

- Renewal License If you have applied for a license renewal and have received a 150-day temporary license ("Notice of Withholding,") you will not be issued a license until both the \$95 fee and the proper DCSS release have been submitted, as noted in the enclosed letter. When both the proper DCSS release and \$95 payment have been received within your 150 day temporary license term, a full-term license will be issued. If the fee is not submitted within your 150 day temporary license term, your license status will become withheld/denied. You will then be required to submit the \$95 fee, the appropriate late renewal application, and the appropriate late renewal fee. If your late renewal application is submitted at any time past your two-year license late renewal grace period, you will be required to requalify for license by reexamination. Once the examination has been passed, you will still be required to submit the \$95 fee in addition to a new original license application and appropriate fee.
- > Current License If you currently hold a license and have received a "Notice of Intention to Suspend" your real estate license, the \$95 fee and the proper DCSS release must be submitted within the period indicated on the enclosed letter. When both the proper DCSS release and \$95 payment have been received within the period indicated on the enclosed letter, your license will be released for the remainder of the current license term. If the fee is not submitted during the period indicated on the enclosed letter, you will be required to remit the \$95 fee before any future license applications are processed. Access to certain eLicensing transactions will also be affected.
