17 The Real Estate Commissioner of the State of
18 California ("Commissioner") has caused an investigation to be
19 conducted of your activities requiring a real estate license
20 and, based on the findings of that investigation, is of the
21 opinion that you, BRIAN CHARLES PETTERSON dba Mortgage
22 Solutions Center and JAMES COMPASS dba Mortgage Solutions
23 Center, LLC, have violated Section 10130 of the Business and
24 Professions Code ("Code").

25 1.

26 You, BRIAN CHARLES PETTERSON and JAMES COMPASS, are
27 not now and have never been licensed by the Department of Real

1 Estate of the State of California ("Department") as a real
2 estate broker. At all times material herein, you, BRIAN
3 CHARLES PETTERSON, were and are doing business in the State of
4 California as Mortgage Solutions Center, a business entity not
5 licensed by the Department. At all times material herein, you,
6 JAMES COMPASS, were and are doing business in the State of
7 California as Mortgage Solutions Center, LLC, a business entity
8 not licensed by the Department.

9 2.

10 At all times material herein, you, BRIAN CHARLES
11 PETTERSON, were licensed and/or have license rights under the
12 Code as a real estate salesperson acting in the employ of
13 Fredrick Younan, a licensed real estate broker.

14 3.

15 At all times material herein, you, JAMES COMPASS,
16 were licensed and/or have license rights under the Code as a
17 real estate salesperson, not acting in the employ of any real
18 estate broker.

19 4.

20 All further references to "you" include the parties
21 identified in Paragraph 1, above, and also include the
22 officers, directors, employees, agents and real estate
23 licensees employed by or associated with said parties and who
24 at all times herein mentioned were engaged in the furtherance
25 of the business or operations of said parties and who were
26 acting within the course and scope of their authority and
27 employment.

1 5.

2 During a period of time from approximately
3 February 1, 2008 and continuing through to the present time,
4 you, BRIAN CHARLES PETTERSON and JAMES COMPASS, have engaged in
5 the business of, acted in the capacity of, or advertised a loan
6 modification service and advance fee brokerage using the names
7 Mortgage Solutions Center and/or Mortgage Solutions Center,
8 LLC, offering to perform loan modification services with
9 respect to loans which were secured by liens on real property
10 for compensation or in expectation of compensation and for fees
11 often collected in advance as well as at the conclusion of the
12 transaction. You offered to or contacted lenders on behalf of
13 distressed homeowners seeking modification of the terms of
14 their home loans, principal reduction, foreclosure abatement,
15 loan refinance, and/or short sale services and advice.

16 6.

17 Your acts, BRIAN CHARLES PETTERSON and JAMES COMPASS,
18 as described in Paragraph 5 above, are acts requiring a real
19 estate broker license under the provisions of Code Sections
20 10131(d) and 10131.2.

21 7.

22 You, BRIAN CHARLES PETTERSON and JAMES COMPASS,
23 violated Code Section 10130 by engaging in the activities
24 described in Paragraph 5, above, without first obtaining a real
25 estate broker license from the Department.


1 NOW, THEREFORE, YOU, BRIAN CHARLES PETTERSON, dba
