The Real Estate Commissioner of the State of California has caused an investigation to be made of your activities requiring a real estate license and, based on the findings of that investigation, as set forth below, is of the opinion that you, LOSS MITIGATION SERVICES INC., a California corporation, DEAN SHAFER, Chief Executive Officer of Loss Mitigation Services Inc., BERNADETTE PERRY, MARION ANTHONY PERRY aka Tony Perry, REBECCA SUANNE BLAKE, LUIS MEYER, LESLIE PIENIAZEK, ANGIE AGUILAR, ALEX AGUILAR, KRIS KELLER, ROBERT MARTINEZ and REY REYES, have violated Section 10130 of the Business and Professions Code (Code).

You, LOSS MITIGATION SERVICES INC., DEAN SHAFER,

BERNADETTE PERRY, LUIS MEYER, LESLIE PIENIAZEK, ANGIE AGUILAR, ALEX AGUILAR, KRIS KELLER, ROBERT MARTINEZ and REY REYES, are not now and have never been licensed by the Department of Real Estate of the State of California (Department) as a real estate broker.

B. You, MARION ANTHONY PERRY and REBECCA SUANNE BLAKE, are expired licensees. Your salesperson licenses expired on December 17, 2008 and July 24, 2008, respectively. Pursuant to Code Section 10201, you retain license rights until December 16, 2010 and July 23, 2010, respectively. The Department retains jurisdiction over your expired and lapsed licenses pursuant to Code Section 10103.

All further references to "you" include the parties identified in Paragraph 1, above, and also include the officers, directors, employees, agents and real estate licensees, unlicensed employees, loss mitigation agents, loan modification consultants, loan modification specialists, and mitigation representatives, employed by or associated with said parties including LOSS MITIGATION SERVICES INC. and who at all times herein mentioned were engaged in the furtherance of the business or operations of said parties and who were acting within the course and scope of their authority and employment. 111

During a period of time from approximately February 2008 and continuing to the present time, you LOSS MITIGATION SERVICES INC., DEAN SHAFER, BERNADETTE PERRY, MARION ANTHONY PERRY, REBECCA SUANNE BLAKE, LUIS MEYER, LESLIE PIENIAZEK, ANGIE AGUILAR, ALEX AGUILAR, KRIS KELLER, ROBERT MARTINEZ and REY REYES, engaged in the business of, acted in the capacity of, or advertised a loan modification service and advance fee brokerage using the names of LOSS MITIGATION SERVICES INC. and Loss Mitigation Services.

- B. You engaged in the business in soliciting for, offering, and performing loan modification services with respect to loans which were secured by liens on real property for compensation or in expectation of compensation and for fees often collected in advance as well as at the conclusion of the transaction.
- C. You solicited distressed homeowners by direct and indirect solicitation including but not limited to mailings and Internet advertising by your website www.lmslossmit.com, and negotiated with lenders on behalf of said homeowners seeking modification of the terms of their home loans, principal reduction, loan restructuring, foreclosure abatement, forbearance plans, loan refinance, deed in lieu of foreclosure, and/or short sale services and advice; and
- D. You collected advance fees within the meaning of Code Section 10085 by written agreement with the homeowners without first submitting these advance fee agreements and

related materials to the Commissioner for review before using them with consumers.
