- 2. At no time herein mentioned has TRANSWORLD BUSINESS ADVISORS OF TRI-VALLEY been licensed by the Department in any capacity.
- 3. At no time herein mentioned has TRI-VALLEY BUSINESS ADVISORS, LLC been licensed by the Department in any capacity.
- 4. At all times herein mentioned, TRANSWORLD BUSINESS ADVISORS was and is a business brokerage company headquartered in West Palm Beach, Florida, specializing in the solicitation, negotiation and sale of businesses, mergers and acquisitions, and franchises. TRANSWORLD BUSINESS ADVISORS operates throughout the United States, including California, through its subsidiaries and/or partnership entities.
